



# **COVENANT REVIEW**

#### The Riverview Executive Committee

As you know, we implemented Protective Covenants for our neighborhood in 2001. To date, 108 of 149 homes have signed the Covenants. These Covenants protect our neighborhood from excesses. However, they bring with them obligations to the individual homeowner. Listed below are some facts about some popularly misunderstood areas:

- When the Covenants have been signed for your property, it acquires permanent mandatory membership in Riverview Associates and you and all future owners are members of the Riverview Association and share in the mutual benefits and responsibilities of the Protective Covenants.
- All members of the Association must pay their annually assessed dues and a lien is automatically applicable to their property for any unpaid amounts.
- Only members can vote at Association meetings.
- If you operate a business from your property this must not be apparent from outside and must be consistent with the residential character of the property.
- You must not build within 20 feet of the side boundary of your lot (note that this is different from and more restrictive than the local building code).
- All exterior building plans must be submitted to the Executive Committee of the Association and must receive their written approval based on the plans conforming to the Covenants.
- No trailers, temporary structures, disorderly or unsightly conditions shall be visible from the street for more than 30 days per calendar year.
- No boats, trailers, trucks over one ton, or commercial vehicles may be parked on the property visible from the street for more than 30 days per calendar year.

These are just guidelines. For more detailed information, please consult the Covenants. Copies can be obtained from the Executive Committee of the Association."
